INTRODUCTION

3D food printing is an interesting technology for offering personalized, healthy, good, appetizing and diversified food. However, it is still difficult to predict the print quality of the new printable recipes. A printable wheat flour based dough can be obtained by applying a thermomechanical treatment^{1,2}. In this work, a wide variety of food matrices for 3D printing were formulated from flours (wheat, rye, soy, lentil) and fruit and vegetable purees (potato, chestnut, broccoli) with the idea of generating a large range of printed products to study printing quality criteria.

OBJECTIVES

The objective of this work was to highlight one or several criteria to evaluate and predict food printing quality in an objective way.

Criteria under study covered the following properties of printed products:

- □ Visual (image analysis)
- □ Rheological (rheometer)
- ☐ Textural (texture analyser)

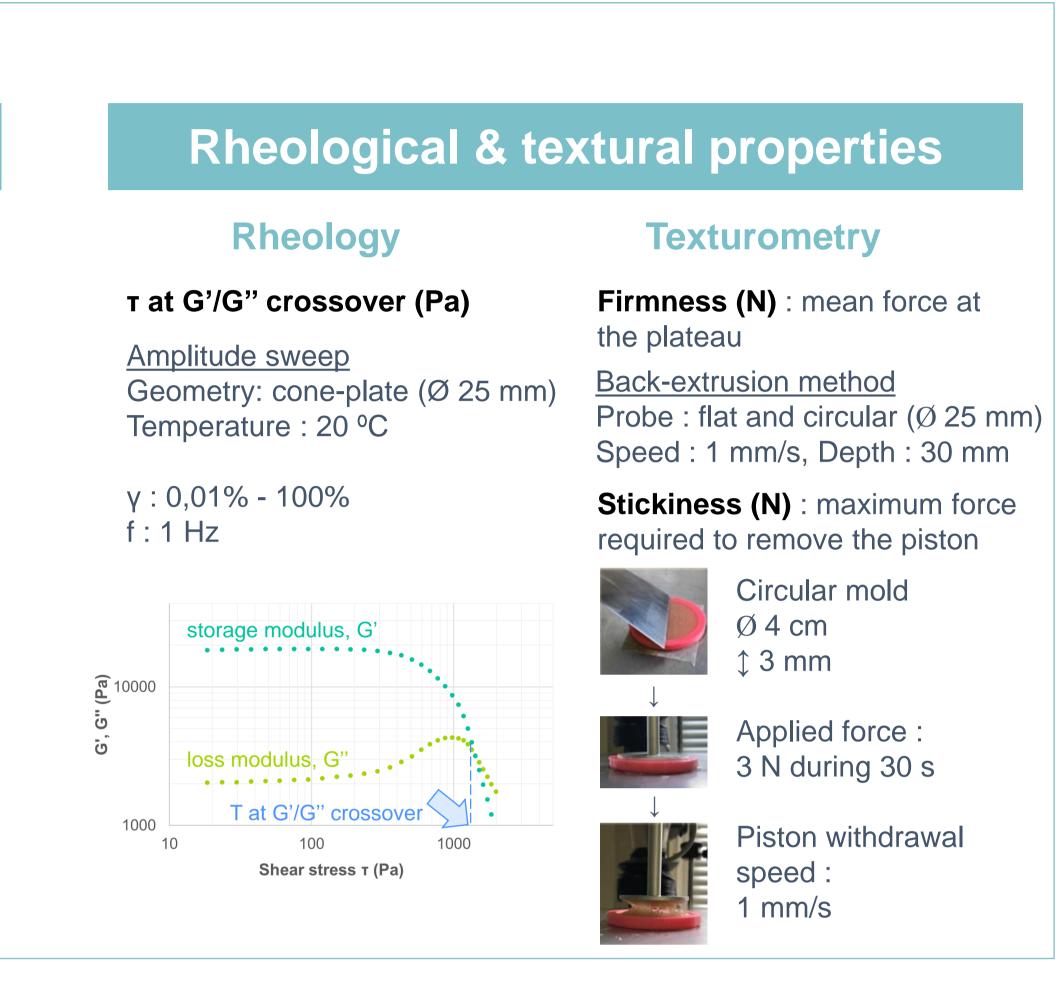
METHODOLOGY

Printed products Floui Water Soy Lentil Chestnut 100% **Puree** Potato without TT Chestnut Potato (no thermomechanical process) **Puree** Water Potato 80% Potato 70% (+10% wheat flour)

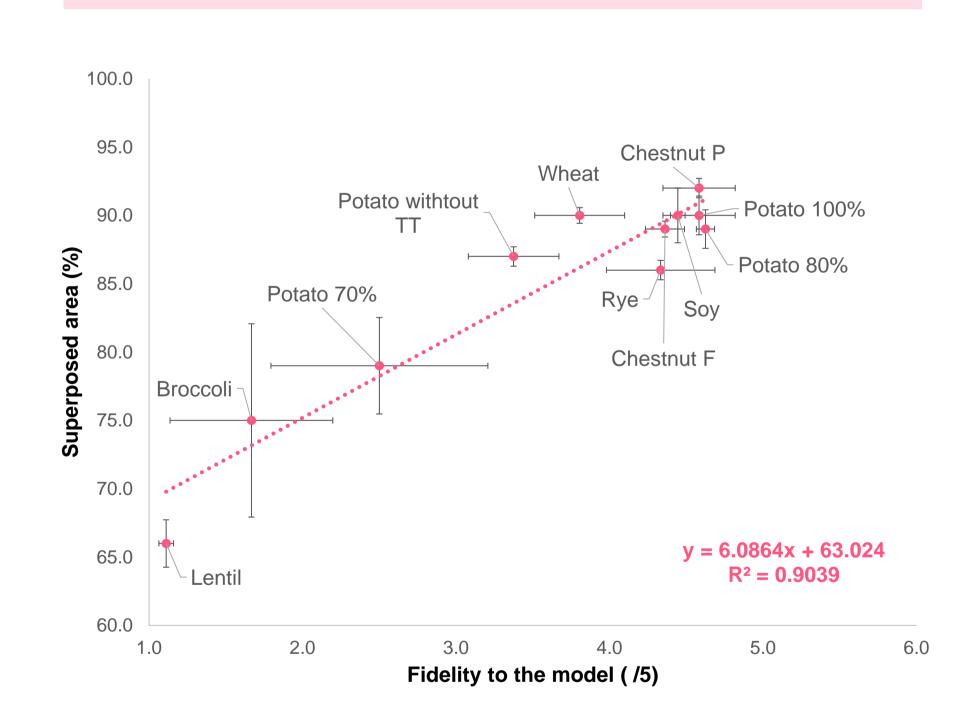

Results and discussion

Image analysis as a representative tool?



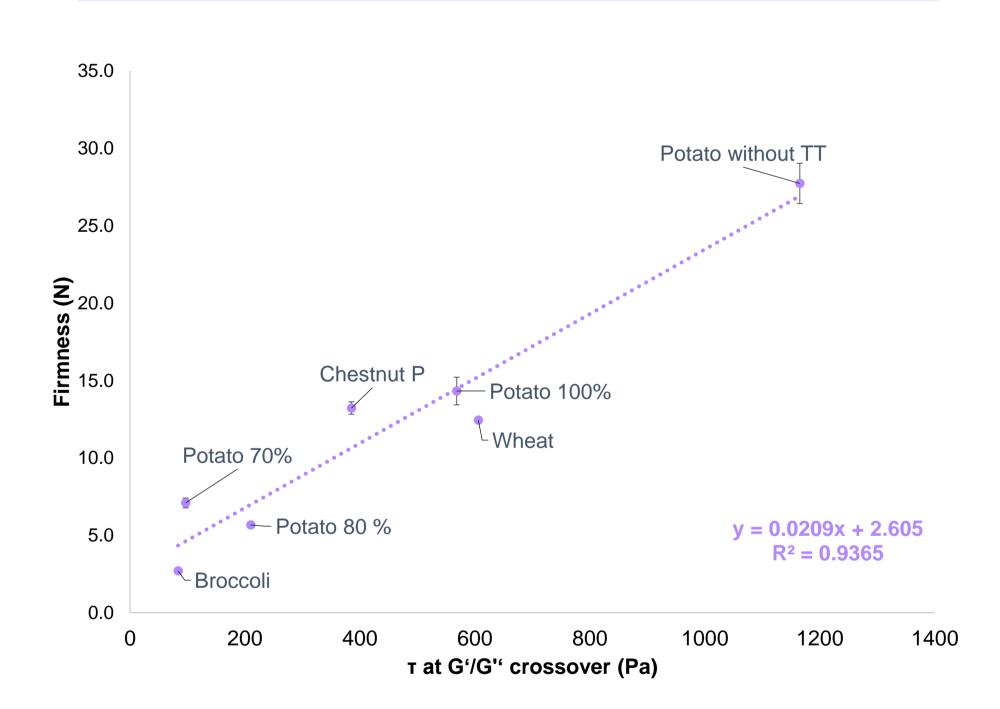
The image analysis protocol developed allows to describe the print quality in a reliable and objective way, and is representative of the scores given by the judges:

A linear relationship ($R^2 = 0.90$) is observed between the superposed area (%) and the model fidelity score.

Same results are observed for the collapse $(R^2 = 0.90)$, but the continuity of the printed layers is less representative of the printing quality ($R^2 = 0.54$).

Textural and rheological properties impacting printing behavior and quality?

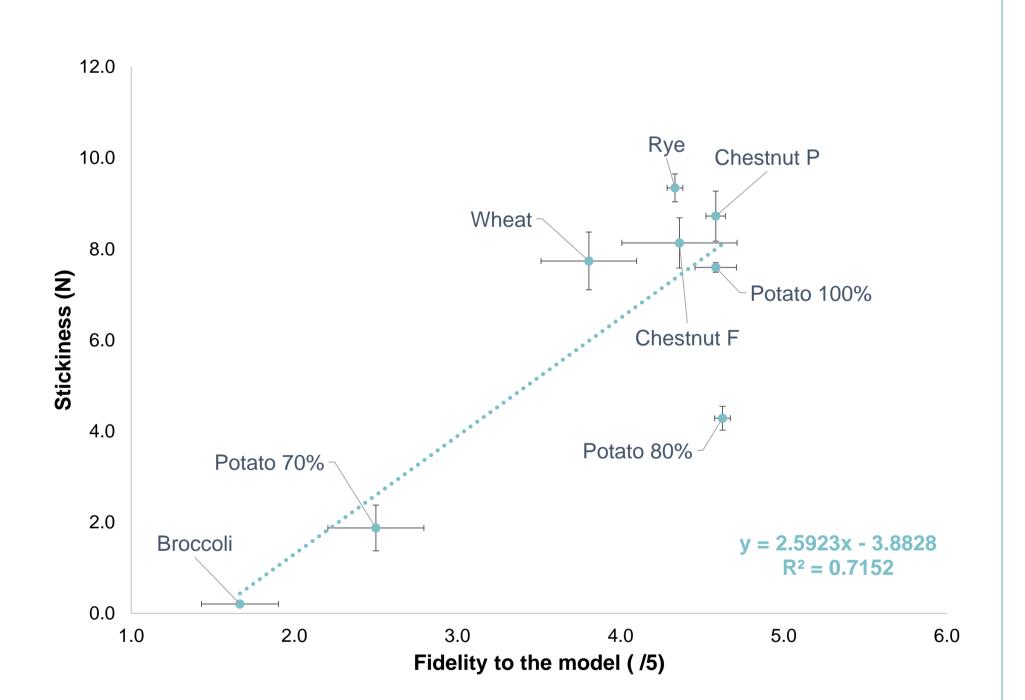


The back extrusion mean force (firmness, N) of the printed products is linked to stress at G'/G" **crossover (Pa)** $(R^2 = 0.94)$:

When the stress at G'/G" crossover is higher, the back-extrusion mean force (firmness, N) increases which can result in an increase in the force required to extrude the product and impact the print quality.

A similar relationship was demonstrated for food matrices based on tomato puree³.

Stickiness, a relevant criterion?



The stickiness (N) of the printed products seems to partially explain the printing quality ($R^2 = 0.72$):

The model fidelity score is higher when the stickiness value increases.

However, the relation between the stickiness and the fidelity score is less obvious than between mean force (firmness, N) and stress at G'/G" crossover (Pa).
